1 Apologies

English Heritage wanted a building more in keeping with a Grade II listed building. This proposal is too modern. The applicant also indicated the proposed size of building maybe reduced. The meeting approved in principle but also agreed the size should be reduced. We believe the applicant is in negotiations with Planning regarding proposed changes. Madge Shineton had indicated a prior meeting she would investigate the planning consent or otherwise for the building down Moors Lane.
